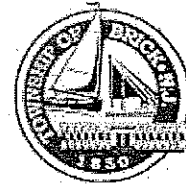

On 08/18/2020 at approximately 2029 hours, Ptl. Pagnotta #301 and I responded to 126 Cartagena Drive in reference to a potential violation of a restraining order (FV-15-000256-21)

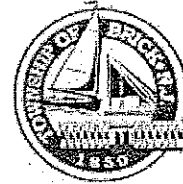
Upon arrival to the residence I was met by Lois Izzo. Ms. Izzo advised she has a restraining order against her son, Michael Izzo, and believed he had responded to the residence to install surveillance cameras at the residence. I asked her why she believed this and she stated she believed Detective Bennett #279 had removed the cameras on the exterior of the property at an earlier date and today observed cameras on the exterior of the residence. She further stated there were two hand prints on the basement window that she did not recall observing in the past.

After I spoke with Ms. Izzo, I contacted Detective Bennett to discuss the matter. Detective Bennett advised he did not remove the cameras from the residence and only unplugged them. Detective Bennett was also able to describe the location of each camera in question. The camera in question was checked and still remained unplugged.

It was at this time I advised Ms. Izzo the cameras have remained on the residence and were never removed by Det. Bennett. I then discussed the hand prints on the window in question with Ms. Izzo and she agreed the hand prints may have been from an earlier date. As a result of the above mentioned, this incident was not believed to be a violation of the order in question.

On 2/28/20 at approximately 1235 hrs. Ptl. Testa #265, Sgt. Jenssen #225, and I responded to 126 Cartagena Dr. in reference to a 30 year old male unconscious.

Upon arrival I spoke with the caller, Michael Izzo. He stated that his friend, Steven George, is currently on the couch and not responding to anybody. He stated George arrived at his house on 2/26/20 at 1700 hrs. and asked if he could stay for a couple of days. He advised that George has used drugs in the past but did not observe him to take anything recently. He stated that George was acting normal until approximately 0830 hrs. 2/28/20. Izzo advised that George has not slept since he arrived at his house on 2/26/20 and only took a brief nap on 2/28/20 between 0800 hrs. and 0830 hrs.. Once he woke up from that nap George began rambling incoherent sentences and would fluctuate from yelling to falling a sleep briefly. Izzo was not sure of any medical history for George other than he suffers from [REDACTED]

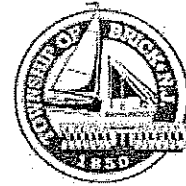
After speaking with Izzo I attempted to speak with George. He was sleeping, sitting upright on a couch. I was able to wake him at which time he began screaming random words before quickly falling back to sleep. George was unable to answer any of my questions. At this time police EMS responded and began to treat George while I attempted to find any of his identification. I was only able to locate his clothes, a prescription bottle of [REDACTED] with his name on it, and a pack of cigarettes. While checking inside the pack of cigarettes, I noticed a plastic bag containing some kind of crystallized substance, possibly methamphetamine. The plastic bag was taken into property and eventually placed inside the property room located inside headquarters.

While first aid treated George, he became combative and needed to be placed in protective custody for his own safety as well as for EMS' safety. He was transported to Ocean Medical Center without incident and was turned over to hospital staff.

Det. Firneno #283 was contacted and advised of the incident.

On 10/24/19 at 1227 hours Christine Nugent responded to Brick Police headquarters in reference to a theft report.

At headquarters Nugent advised the following about the above incident:

In April 2019 Nugent contacted, PM Pools, located out of 126 Cartagena Dr. in Brick, to respond to her home located at, [REDACTED] in Bernardsville New Jersey, for a pool opening service. During the process, the company removed her \$9,000.00 cover and brought it back to Brick without her agreeing for such service. When she contacted the owner, Michael Izzo, he stated that there were minor holes through out the cover and that he was going to repair it while storing it.

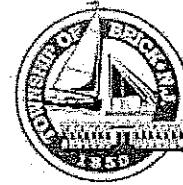
Believing this was an honest business practice, Nugent agreed and also paid Izzo \$1,500.00 up front for weekly cleanings. Everything seemed to be going smoothly, until the end of April when the company suddenly stopped showing up. Nugent attempted to contact Izzo over their business agreement but she was unable to get a response despite her constant phone calls and 50 emails.

Since then Nugent has had to find a new pool company and has yet to have her pool cover returned. She is unable to close her pool and is worried it will not be returned.

It should be noted that this is the second incident involving this Pool company that the homeowner was unable to retrieve their pool cover from Izzo.

On 03/19/2018 at 1653 hours Lois Izzo and Michael Izzo responded to police headquarters to report an incident of forgery. I, Ptl. Newlund #285, escorted both parties into the police interview room.

In speaking with Lois, she advised she technically still owns a pool business, called PM Pool, with her previous husband Alfred. Lois further advised in early 2017 both owners of the company were in negotiations with Onelia Martin to sell the business. Lois explained during the negotiations Martin began working for the company, overseeing all operations of the company. Lois stated in July 2017 she was advised by Alfred that he was no longer paying the alimony through his pay checks and that she was now considered an employee of the new company Martin had established called PM Pools Service. Lois advised she contacted Martin and advised her that she never signed a W-4 statement making her an employee of the company and should not be getting paid as if she was an employee of either company. Lois further advised during the phone conversation conducted on speaker phone (on 02/15/2018), Martin admitted to signing Lois name on the W-4 form (with Michael present in the room to hear the conversation). Lois explained prior to the phone conversation on February 15, 2018, she received a W-2 form stating she was an employee of PM Pools Service and received wages of \$17,307.75. Lois explained Martin is not attempting to correct the issue in any type of actions.

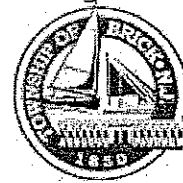
After speaking with Lois, I spoke with Michael. Michael advised he was present in the room when the conversation occurred on February 15, 2018 between Lois and Martin. Michael further advised he heard Martin admit she forged Lois name on the W-4 form.

After speaking with Lois and Michael, I advised them I would document the incident and provided Lois with the case number. Lois provided me with a copy of the W-2 form she received and the forged W-4 form. These documents were attached in this case form.

On 7/9/19 at about 1443 hrs. I was at 126 Cartagena Dr. for an unrelated incident (C#46495-17). Michael Izzo reported that in April 2017 he checked his credit report and found unauthorized charges on his Mayors charge account.

Izzo stated that he had been in contact with Mayors and reported the fraud. He stated that Mayors sent him paperwork to dispute the transactions and instructed him to file a police report. He stated that Mayors did not divulge much information to him other than the fraudulent charges were made in Jacksonville, FL and the credit card was not present.

Izzo provided copies of four statements showing the fraudulent charges. The charges are as follows:

1. 12/6/16 \$1,125; 2. 12/9/16 \$3,187; 3. 2/24/17 \$13,074; 4. 4/23/17 \$10,085. There were also returns listed that were also fraudulent.

Izzo was still in possession of the credit card. He could not identify any suspects, but speculates that Mayors employees may be involved. Izzo filed a fraud alert with the credit reporting bureaus. Copies of the statements were filed with this report.

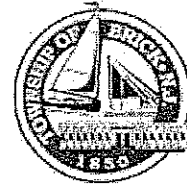

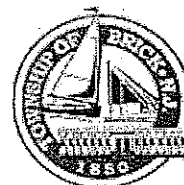
Upon arrival, we met with complainant/victim, Lois Gayle Izzo. Lois advised that there was an alarm going off in the house prior to Police arrival. Lois further advised that the garage door, that is controlled by an automatic garage door open, had opened on its own. Lois stated that no one in the home opened the garage door.

Lois advised that she does not know anything about the alarm system or any wifi-controlled devices inside the home. She believes that her son, Michael Alfred Izzo, set the alarm off and opened the garage door remotely from a different location. Lois stated that Michael is restrained from the residence currently. She stated further that he set up an elaborate computer network in the home and has electronically stolen large amounts of money from her and her family.

While officers were on scene, the alarm remained silenced. The the alarm control panel was removed from the wall by Lois prior to officers arrival. Lois asked if there was any way I could close the garage door for her. I was able to disconnect the garage door from the garage door open track, by removing the pin, so as to close the garage door. Lois was advised of the procedure to re-attach the garage door to the garage door opener track.

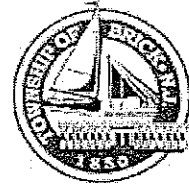

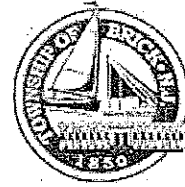

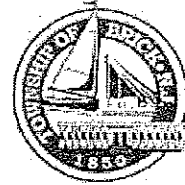
