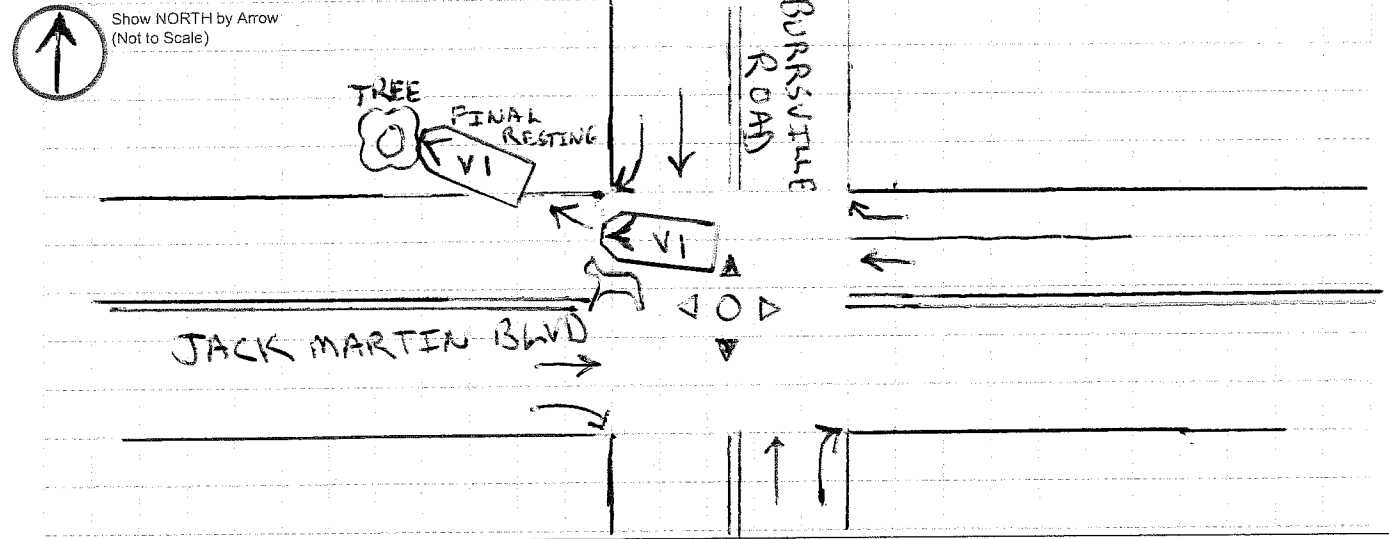

145. Crash Description/Narrative

DRIVER #1 STATED THAT SHE WAS TRAVELING WEST ON JACK MARTIN BLVD. SHE JUST WENT THROUGH A GREEN LIGHT AT THE INTERSECTION WITH BURRSVILLE RD WHEN A LARGE ANIMAL RAN OUT INTO THE ROADWAY. THE ANIMAL CAUSED HER TO SWERVE GOING OFF THE RIGHT SIDE OF THE ROADWAY STRIKING A LARGE TREE. THE ANIMAL WAS NOT HIT BY HER VEHICLE AND RAN AWAY. DRIVER #1 REFUSED FIRST AID.

THE TREE HAD NO DAMAGE.

DRIVER #1 WAS REVOKED AND ISSUED A SUMMONS FOR 39'3-40
