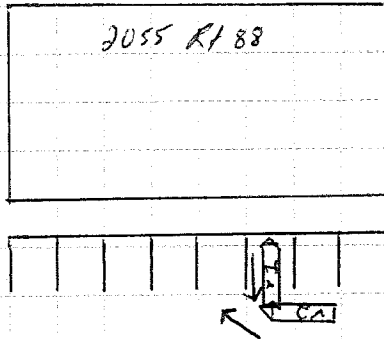

145. Crash Description/Narrative

On scene investigation concluded: V#1 and #2 were traveling in the parking lot of Discount Mattress, 2055 Rt 88. V#1 was backing out of a parking stall when V#2 was attempting to park in an adjacent parking stall. V#1 backed into V#2.
