UPON APPROACHING THE DRIVERS SIDE WINDOW I MADE CONTACT WITH THE OPERATOR OF THE VEHICLE WHO IDENTIFIED PER HIS NJ DL AS IAN SMITH. I COULD IMMEDIATLEY DETECT AN ODOR OF ALCOHOLIC BEVERAGE ON MR.
