You filed an OPRA request with the Department of Law and Public Safety (L&PS), Office of the Attorney General (OAG) seeking access to: "copies of all OPRA requests from August 1, 2017 to November 20, 2017."

93 OPRA requests were filed with OAG between August 1 - November 20, 2017. In response to your request, I am providing you with an electronic copy of a 28 page report which contains the following information from those 93 OPRA requests: Request #; Division; Date/Time; Requestor; Company Name; Address; Email Address; and Requested Information. Records have been redacted for one or more of the following reasons: Social Security number, driver's license number, credit card number, Federal Tax Identification Number (FEIN), legislative exemption, information whose disclosure would violate a citizen's reasonable expectation of privacy. Such information includes, but is not limited to, home address, personal email address, and date of birth. see *Wolosky v. Somerset Cty.*, 2017 N.J. Super. Unpub. LEXIS 781 (App. Div. 2017).

Reporters and news organizations filed OPRA requests with OAG during this time period seeking access to records for research and background in connection with articles and news stories that they contemplated writing and publishing. The Appellate Division noted in *Gannett N.J. Partners, LP v. County of Middlesex*, 379 N.J. Super. 205, 212 (App. Div. 2005) that a news organization might have a competitive interest in maintaining the confidentiality of its request for government records under OPRA. As you are a media company and have announced that you will post these records on the Internet, there is not just "mere potential", but rather a clear showing that disclosure of information contained in OPRA requests recently filed with OAG by reporters would give a competitive advantage to competing reporters, news organizations and media companies. For that reason, I have redacted portions of the "Requested Information" from OPRA requests filed by members of the press on the grounds that those OPRA requests contain information which, if disclosed, would give an advantage to competitors. N.J.S.A. 47:1A-1.1.
